

Applicant Requirements:

- Completed Application
- Certificate of Liability Insurance
- Proof of Equipment Operational Condition (1 Year)
 Choose ONE of the following:
 - Maintenance/service records
 - Revenue and usage records with operational, standby, and down hours for equipment
 - Routine inspections which document operating condition of equipment (OSHA or workplace required)
- Proof of Existing Equipment Ownership, Operation, and Residency in CA (2 years)
 - Bill of sale for existing equipment and
 One of the following:
 - Tax depreciation logs
 - Property tax records
 - Equipment insurance records
 - Bank appraisal for equipment
 - Maintenance/service records
 - General ledgers
 - Fuel records specific to existing equipment
 - Other:
 If no bill of sale, must provide 2 items from list above
- Proof of Existing Equipment Usage (2 years) Choose ONE of three options below:
 - Option 1: Hour meter reading log (collected at least once per year)
 - Option 2: Fuel records specific to equipment
 - Option 3: Provide at least TWO of the following:
 - Revenue and usage records with operational, standby, and down hours for equipment
 - Employee time sheets linked to equipment usage
 - Preventive maintenance records tied to specific usage hours for equipment
 - Repair work orders specific to equipment
 - Six months tracking normal equipment usage with functional, tamper-proof hour meter
- Tier 3 Engine Repower Cost Estimate for Existing Engine
 Or Submit a Dealer statement indicating that a Tier 3 engine repower is NOT available for equipment
- Replacement Equipment Documents
 - Replacement Engine ARB Certification (Executive Order)
 - Replacement Equipment Price Quote & Spec Sheet
 - Replacement Engine & Drive Train Warranty Documents
- Retrofit Documents, if applicable
 - New Retrofit ARB Certification (Executive Order)
 - New Retrofit Price Quote & Spec Sheet
 - New Retrofit Warranty Documents

After Contract is Signed:

- Submit Replacement Equipment & Retrofit Purchase Order showing order date, price, estimated delivery date

After Replacement Equipment is Delivered:

- Submit Proof of Applicant's Cost Share Payment--copy of check/finance documents
- UCC-1 Form
Submit proof that UCC-1 Form(s) have been filed with California Secretary of State, giving FRAQMD a security interest in the Replacement Equipment for the full contract amount of the grant funds paid to Applicant
- Destruction of Existing Equipment
NO part of existing equipment can be re-used or kept by Applicant
