WHEREAS, the California Rules of Professional Conduct require that legal counsel disclose any actual or potential conflict of interest and obtain the informed written consent of the Board of Supervisors of the County of Sutter and the Board of Directors of FRAQMD before advising or representing FRAQMD regarding the agreement for use of Motor Vehicle Registration Surcharge Fees; and

WHEREAS, it will be beneficial to FRAQMD to have the Sutter County Counsel advise and represent both FRAQMD and the County of Sutter due to the commonality of issues and interests relating to the agreement for use of Motor Vehicle Registration Surcharge Fees;

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors for the Feather River Air Quality Management District as follows:

The Board of Directors for the Feather River Air Quality Management District hereby waives any actual and/or potential conflict of interest and consents to the Sutter County Counsel advising and representing FRAQMD for all matters relating to the agreement for use of Motor Vehicle Registration Surcharge Fees.
