## APCO Update:

Mr. Brown gave an update on Sacramento Region activities. Mr. Brown stated that the main issue was the CTR issue. There was supposed to be a joint entity conference call with Mr. Phil Serna but he was called away on a COVID-19 meeting and has not rescheduled at this time.

Mr. Brown gave an update on the Grant Program which included the Community Air Protection Incentive Grant, Mini Grants and the Moyer Grants programs.

## **Board Member Reports**

Director Samayoa requested that Mr. Brown keep the City of Marysville informed on the grant projects.

Director Pendergraph inquired as to whether the District needed to draft a letter regarding the impact to the counties and cities from the trucks hauling the debris waste from the Camp Fire to Ostrom Road Recology.

Mr. Brown stated that he did not believe we needed a letter at this time but that it might be needed in the future.

Director Samayoa stated that funding had been provided through CAP Funding for the Highway 70 project and that CalTrans was looking for feedback concerning B Street and the Train Tressel and advocating for sidewalks and lights by the High School.

With no further business Chairman Conant adjourned the meeting at 5:03 p.m.
