APCO Update: (Informational Only)

Mr. Brown gave an update on Legislation which included funding of approximately \$1.5 billion gifted to the Air Resources Board and other state agencies for Cap and Trade, \$27 million from AB617 to be distributed to the Air Districts, \$5 million for the Woodstove Program to be distributed to the Air Districts, and \$85 Million in additional funds for Ag Incentive Funding, and enhancement to the Carl Moyer Program.

Mr. Brown gave an update on District activities which included hiring a new Engineer and a new Administrative Assistant, and stated at this time the District is fully staffed.

Mr. Brown gave an update on the Hearing Board activities in which he stated that there had been no meetings and there was still one vacancy.

Mr. Brown gave an update on the EPA and stated the main issue was the SIP which the Board had just approved.

Mr. Brown gave an update on the BCC, and stated there will be a meeting on October 6, 2017.

Mr. Brown gave an update on the Grants program in which he stated that the Blue Sky Grants Program had started and applications would be accepted until October 16, 2017 and then the Mini Grant Program will begin. Mr. Brown stated that the District would be setting up a Policy/Finance Committee meeting in November to discuss and recommend the Blue Sky Grants to bring back to the December Board meeting for approval.
