### APCO Update:

Mr. Brown gave an update on District activities which included the District now being fully staffed, the District getting Purple Air Monitors from the Air Resources Board to distribute throughout the District and an update on the fires and the effects they are having with the air quality in both counties and the surrounding areas.

Mr. Brown gave an update on the District Hearing Board which included that there could be an Emergency Variance for one of the District Sources and there is still one vacancy that needs to be filled and one that is coming up for renewal in October.

Mr. Brown stated there was nothing to update regarding the Air Resources Board.

Mr. Brown gave an update on the EPA which included the mileage roll back program.

Mr. Brown gave an update on Legislation which included there would be additional funding for CalFire crews to do controlled burns and air monitoring, which should be handled through the Air Resources Board.

Mr. Brown gave an update on the BCC which included the meeting last week was cancelled due to the fires and that a new Burn Coordinator had been hired and training has started to get ready for the Rice Burn season.

Mr. Brown gave an update on the Grant Programs which included the Woodstove Program and this year's program will last through December.

Mr. Brown gave an update on the Sacramento Region Activities which included an upcoming meeting with Phil Serna.

Mr. Brown gave an update on AB617 which included an upcoming Public Outreach event with the County Health Officers.

Ms. Micheli, District Counsel stated that Closed Session was not needed.

### Board Member Reports

Director Conant stated that the fires are causing a lot of problems due to no grazing allowed and no Co-Generation Plants, and suggested that the District could encourage the State to be more proactive on the preventative side.

Mr. Brown stated that his counterpart in Glenn County who is the Ag Commissioner has a gentleman who is associated with the grazing community who wants to make a presentation to the Air Pollution Control Officers. He will be at the meeting in late August to talk about grazing

which we don't have much information on. Mr. Brown also stated that he would push a Bio Mass Conference which has been talked about but no one has taken the lead on it.

With no further business Chairman Pendergraph adjourned the meeting at 4:52 p.m.
